### GENERAL ORDER NO. 41

## ASSIGNMENT OF CIVIL CASES TO UNITED STATES MAGISTRATE JUDGES

Commencing on March 1, 1996, or as soon thereafter as possible, the full-time United States Magistrate Judges in the Northern District of California shall be included in the civil case assignment system in the same manner as the United States District Judges, except that no capital cases, bankruptcy appeals or bankruptcy withdrawal of reference cases will be assigned to Magistrate Judges. The percentage of the District's civil caseload assigned to each Magistrate Judge will be as the Assignment Committee from time to time instructs.

In cases assigned to a United States Magistrate Judge, the Magistrate Judge shall conduct all further proceedings including a jury or bench trial and shall order the entry of a final judgment upon the consent of all parties in the case in accordance with 28 U.S.C. § 636(c). Cases assigned to a Magistrate Judge shall not be assigned to a United States District Judge unless a party declines to consent.

In all cases assigned at filing to a Magistrate Judge in which Plaintiff is represented by counsel, the Clerk of Court shall provide all parties with a Notice of Assignment of Case To A United States Magistrate Judge for Trial (Exhibit A) and a Request for Reassignment To A United States District Judge (Exhibit A-1). Unless a party represented by counsel requests reassignment of the case to a United States District Judge within 30 days after his or her initial appearance, that is, 30 days

after the complaint is filed, in the case of Plaintiff, or 30 days after an answer or motion to dismiss is filed, in the case of Defendant, the parties will be deemed to have consented to trial and disposition by the assigned United States Magistrate Judge pursuant to 28 U.S.C. § 636(c) and Rule 73, Federal Rules of Civil Procedure.

In all cases assigned at filing to a Magistrate Judge in which Plaintiff appears in propria persona, the Clerk shall provide all parties with a Notice of Assignment of Case Involving Pro Se Party To A United States Magistrate Judge For Trial (Exhibit B) and a Consent to Assignment or Request for Reassignment (Exhibit B-1). All parties shall return this form within 30 days after their initial appearance, that is, 30 days after the complaint is filed, in the case of Plaintiff, or 30 days after an answer or motion to dismiss is filed, in the case of Defendant.

If a party declines to consent to a United States Magistrate Judge and requests reassignment, the Clerk shall reassign the case to a United States District Judge on a random basis.

The plaintiff shall serve a copy of this notice and attachments immediately upon all other parties that are served with the summons and complaint pursuant to Rules 4 and 5, Federal Rules of Civil Procedure.
