- 1) The commission of the offense involved a substantial loss or damage to the property of the United States or another;
- 2) The commission of the offense involved a serious threat to the safety or welfare of others: or
- 3) The offender has committed the same or similar offenses on prior occasion(s).

In all cases in which the California Bail schedule is adopted, use the amount in the "Total Bail" column in the current California Uniform Bail and Penalty Schedules which are incorporated by this reference.
